The Company entered into a loan agreement with HSBC on October 30, 2017. According to the loan agreement, the Company received a loan of HK\$110,000 from HSBC for a period of 12 months. The loan bears interest of 9.60% per annum and is payable at a fixed amount of HK\$10,047 per month. As of March 31, 2018, the loan balance was HK\$64,343 (\$10,567) (December 31, 2017 - HK\$92,487 (\$14,852)).
