During the month of June, 2021, the Issuer was continuing to prepare its Brantford facility and equipment for start-up operations, its wholly-owned subsidiary having received a processing license from Health Canada effective April 30, 2021. The Processing License allows the company to produce cannabis edibles and related

products and will also allow the company to conduct development activities, including the formulation of proprietary cannabis infused edibles.

During the month of June, 2021, the Issuer also assisted Budd Hutt Inc. ("Budd Hutt"), a private company that the Issuer owns a 27.5% interest in, with the completion of its second retail cannabis store opening in Grand Cache, Alberta. Budd Hutt is a private retail cannabis company that is expected to provide the Issuer distribution opportunities for its cannabis edible products in the future.

During the month of June, 2021, management of the Issuer was active in:

- *continuing to complete quality systems and operational procedures to produce the following edibles upon receipt of the Processing License: filled and solid chocolates, gummies in blister packaging, baked goods (such as: cookies, protein and granola bars) and pet snacks*
 - *sourcing information and preparing a budget for additional food manufacturing equipment and related ancillary equipment*
 - *assisting Budd Hutt with its second retail cannabis store opening (refer to Item 1 above)*
 - *continuing its due diligence relating to the potential acquisition of Blue Heaven Café.*
