During the first two weeks of June, the Issuer completed a prospecting campaign on its Sakami property. This campaign involved the work of four geologists, a geologist in training, one engineer and they were supported by four technicians, a helicopter pilot, a cook and a camp manager. The main purpose of this program was to work on the newly discovered Lamarche, GoldenEye and Transtaiga zones in order to enhance the geological comprehension of the zones and to better comprehend the geological setting the extent of the mineralization. Furthermore, the regional exploration of the property was continued by targeting anomalous areas highlighted by the recent drone MAG and IP Surveys completed in 2020 and 2021 respectively. Out of 9 days of intensive prospection work, a total of 200 outcrops were described, 249 rock samples were collected and 13,4m of channel sampling was realised on the Transtaiga showing.

On other properties, the Issuer was inactive for the month of June.
