The Company has begun its Phase 2 clinical trial for IPF and chronic cough announcing its first patient dosed on August 5, 2020.

The Company has also begun its multinational Phase 2b/3 clinical trial for IPF and chronic cough having announced its first patient enrolled on August 5, 2020.

Due to a lack of sufficiently ill patients, which is a direct result of a highly-successful government initiated pandemic mitigation strategy, the Company has decided to close the investigator-led South Korea trial of Ifenprodil for COVID-19.

On Oct. 09, 2020 the Company announced that Dr. Mark Swaim, a former practicing physician and researcher has joined the Algernon Medical and Scientific Advisory Board.

On Oct. 13, 2020 the Company announced that it has reached 25% of its enrollment target for its Phase 2 idiopathic pulmonary fibrosis (IPF) and chronic cough clinical study of its re-purposed drug NP-120 (Ifenprodil).

On Oct. 30, 2020 the Company announced that after its second meeting and review, the external Data and Safety Monitoring Board (“DSMB”) has once again unanimously approved the continuation of the Company’s multinational Phase 2b/3 human study of NP-120 (Ifenprodil) for the treatment of COVID-19.
