HealthSpace develops and provides sophisticated information management system for the surveillance, business management, compliance and tracking of regulatory and quality control applications. Clients include government regulatory agencies and private sector businesses who require collected data along with auditing applications for the purpose of improving productivity, quality control and performance analysis.

HealthSpace's ongoing engagement with government customers in both the US and Canada continues to drive growth and viable learning opportunities to continue to innovate our technology offerings. In 2018, we are now actively introducing our platform and services into commercial enterprise clients in food & beverage, hospitality, assisted living, and child-care. Ongoing discovery work based on HealthSpace's agricultural capabilities is now being integrated into cannabis production and distribution processes through work with both US and Canadian partners.

HealthSpace has developed several relationships within the cannabis space and has begun detailing some product changes in order to cultivate market traction. The Company is exploring opportunities with multiple regulatory agencies that oversee and regulate cannabis producers. The Company intends on leveraging its vast experience in developing SaaS platforms for enforcement and compliance into the cannabis space where there is little in the way of software offerings that adequately handle compliance.

 - On October 30, 2018, the Company announced an update on Peterborough Public Health (Peterborough, Ontario) and its work with testing the VIA Marketplace API launched earlier this year. The next phase will include writing all food permit information to the Ethereum blockchain through the VIA protocol. Once completed, this extension will allow citizens to recognize that a food permit or audit posted in paper form inside a food service establishment was actually issued from the Health Department by verifying its lifecycle on the blockchain.
 - On October 31, 2018, the Company announced that the Florida Department of Health ("DOH") posted on MyForidaMarketPlace Vendor Bid System its intent to award a five year contract to HealthSpace USA Inc. a wholly owned subsidiary of the Company subject to successful contract negotiations.

The contract will be for the installation and maintenance of the HealthSpace CS Pro Enterprise Cloud application for the entire State of Florida with over 1,100 concurrent users. DOH provides environmental health services to detect and prevent disease caused by natural and manmade factors in the environment. Further details regarding this contract will be announced once a final contract is signed by both parties.

This contract, when finalized, will be the largest contract ever signed by the Company in terms of gross dollar amount and the number of users. Part of HealthSpace's core business is reviewing and responding to all environmental health related proposals issued by regulatory agencies across North America. As a result of its experience in responding to regulatory agency tenders over the past 21 years, this award represents the largest environmental health regulatory agency contract by dollar amount and number of users.
