The Issuer announced the production of the first laboratory quantities of ammonia at its recently opened, flagship Manufacturing & Development Facility in Southeast Michigan. This event, being the first significant technical achievement to occur at the new Facility, signals the launch of AmmPower's ammonia catalyst and process development programs that are to follow.
