The Issuer entered into an acquisition agreement (the “**Agreement**”) to acquire a 100% interest in a vanadium indicated resource exploration property located in Quebec (the “**Barchois Property**”). The terms of the Agreement call for a onetime payment of \$40,000 and the issuance of 500,000 common shares of the Issuer (“**Shares**”) within 10 business days from the date of the Agreement and 500,000 Shares on or before 12 months from the date of the Agreement.

The Barchois Property is a sedimentary hosted Vanadium-Selenium-Silver-Lead-Zinc prospect in the Gaspé area of Quebec. The project covers 1,801 hectares where Carboniferous aged sediments have been shown to host sedimentary vanadium-zinc-lead mineralization. Historical work has identified three showings with samples yielding Vanadium Pentoxide grades in excess of 2%, lead over 8% and zinc over 5%.

Vendor retains a 2% NSR on the Property, half of which can be purchased, at the option of the Issuer, at any time for \$1.5 million.
