The Issuer acquired all of the outstanding common shares of Isracann Holdings Inc. (formerly, Isracann Biosciences Inc.) (the “**Isracann Holding Shares**”) in exchange for common shares of the Issuer (the “**Transaction**”). The Issuer is now the sole registered owner of all of the outstanding Isracann Holding Shares.

2. Provide details of the acquisition including the date, parties to and type of agreement (eg: sale, option, license etc.) and relationship to the Issuer. The Issuer, Isracann Holdings and securityholders of Isracann Holdings entered into a securities exchange agreement dated March 12, 2019 (the “**Securities Exchange Agreement**”) pursuant to which the Issuer acquired all of the outstanding common shares of Isracann Holdings in exchange for 46,680,000 post-consolidated common shares of the Issuer (the “**Shares**”) at a deemed price of \$0.50 per Share. In addition, all outstanding warrants and options of Isracann were cancelled in exchange for 28,000,000 replacement warrants (the “**Replacement Warrants**”) and 4,000,000 replacement options (the “**Replacement Options**”) of the Issuer, as applicable. The Replacement Warrants are exercisable into Shares at \$0.05 per Share until February 14, 2021. The Replacement Options are exercisable into Shares at an exercise price of \$0.51 per Share until February 14, 2021.

On July 5, 2019, the Issuer obtained shareholder approval of the Transaction at its annual general and special meeting of shareholders. On September 23, 2019, the Issuer received conditional acceptance from the CSE for the Transaction.

On October 7, 2019, the Issuer consolidated its common shares at a ratio of three old Common Shares for every one new common shares and changed its name from Atlas Blockchain Group Inc. to Isracann Biosciences Inc. All Shares issued in connection with the transaction were issued on a post-consolidation basis.

PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9
