The Company is conducting a Phase 2 clinical trial for IPF and chronic cough announcing its first patient dosed on August 5, 2020. The study achieved 25% enrolment on October 13, 2020.

The Company announced on December 24, that the last patient completed treatment as well as the two - week follow up from its multinational Phase 2b/3 Ifenprodil clinical trial for COVID-19. The Company is projecting the final data set will be available before the end of February, 2020.

2. Provide a general overview and discussion of the activities of management.

On January 07, 2021 the Company provide an overview of its primary plans for the upcoming calendar year.

On January 19, 2021 the Company announced that the external Data and Safety Monitoring Board (“DSMB”) has completed its latest review of the Phase 2b part of the Company’s Phase 2b/3 human study of NP-120 (Ifenprodil) for the treatment of COVID-19, and has provided approval for the Company to continue on with the Phase 3 part of the study.

On January 22 2021 the Company announces that as of close of market on January 21, 2021, approximately 23M November Warrants were exercised since their original date of issue resulting in an additional capital contribution of CDN\$2.76M to the Company. Any unexercised November Warrants have now been cancelled. The warrants, trading under the symbol of AGN.WT, were halted by the CSE and have now been delisted.
