During the past month, the Issuer generally continued to market its cloud-based social business software platform for the real estate services industry to real estate agents and brokerages worldwide.

Specifically, on April 6, 2016, the Issuer announced that it reached an agreement with the Miami Association of REALTORS®, the largest local REALTOR® group in America. This five-year agreement will allow all 41,000 members to communicate lightweight listing, referrals, and market insights in a private, centralized and real-time area known as RealTimeMLS.

Also, on April 29, 2016, the Issuer filed its audited annual consolidated financial statements for the year ended December 31, 2015 on SEDAR, together with the accompanying management's discussion and analysis and results of operations and annual information form (AIF). On the same day, the Issuer filed its annual report on Form 40-F with the United States Securities and Exchange Commission and posted its annual Form 2A listing statement with the CSE.
