**Specifically, on June 20, 2016, the Issuer announced that it had signed a five-year agreement with East Bay Regional Data ("EBRD"), a MLS with three member associations across the East Bay in Northern California. This agreement allows all 3,200 agents across those associations to communicate and share listings instantly in a centralized social platform known as RealTimeMLS, the Issuer's flag-ship solution for MLS and real estate associations.**
