Enertopia is exploring a portfolio of three prospective lithium projects in Nevada, and concurrently working with water purification technology that is believed able to recover Lithium from brine solutions, see Company press release dated June 28, 2016 for further information on this technology.

On September 13, 2016 the Company provided an update on its Definitive Agreement with Genesis Water Technologies, Inc. ("GWT") that the Definitive Agreement between GWT and Enertopia is in its final phase of reviews and is expected to close shortly.

On September 19, 2016 the Company reported it engaged Mr. Duncan McKay in a one year investor relations contract.

On September 23, 2016 the Company announce it closed the final tranche of its financing in the amount of CAD\$135,050 for its Private Placement announced on August 8, 2016. Enertopia issued 3,858,571 common shares at CAD\$0.035 and 3,858,571 whole warrants that expire on September 23, 2018 with an exercise price of US\$0.07 during the 24 month term. A cash finder's fee for \$4,830 and 138,000 full broker warrants that expire on September 23, 2018 with the same exercise terms as noted above was paid to arm's length parties. Proceeds of the Private Placement will be used for developing the Lithium Brine division projects and technology and general working capital.
