**The Company's business focus remains on precious metal exploration for resource development in eastern Canada. The Company successfully filed its audited financial statements and MDA for fiscal years ending 2015 and 2016, in addition to filing its financial statements and MDA for Q1, 2017. Mountain Lake Minerals also held its Annual General Meetings on April 24, 2017 at the Westin Hotel in Halifax, Nova Scotia.**

The Company also filed an application for revocation of the cease trade order with the BC, AB, and ON Securities Commissions. Management has been advised that minor review comments from the securities commissions will be received on May 1, 2017. The Company anticipates returning to active trading on the Canadian Stock Exchange in early May following final review from the Canadian Stock Exchange.

The Company continued to raise finances pursuant to its announced private placement on February 21, 2017. Use-of-proceeds are focused on costs and fees associated with revocation of the Company's cease trade order.

Mountain Lake Minerals also continues its on-going discussions with several companies regarding both potential option and financing opportunities.

The Company also completed revised budget and work plans related to its Newfoundland assets.

The Company's main assets include a 100% interest in its Glover Island Gold Project and its Little River Gold-Antimony Property. Both properties are located in Newfoundland, Atlantic Canada.

Management focused on completing and successfully filed its 2015 and 2016 annual audited financial statements and MDA, in addition to its interim financial statements and MDA for Q1, 2017.

The Company also held Annual General Meetings for fiscal years ending 2015 and 2016 at the Weston Hotel in Halifax, Nova Scotia on April 24, 2017. Highlights of the meeting were reported by AllNovaScotia.com in their April 25, 2017 edition.

The Management continued with its private placement financing to complete the Company audits, filings and its annual general meetings. Management continues discussions with several companies related to both financing and option agreement opportunities at its Newfoundland assets.
