Mountain Lake Minerals' (the "Company" or "MLK") business focus remains on precious metal exploration for resource development in eastern Canada.

The Company's primary objective for the month of June, 2017 was directed at its successful application for revocation of its Cease Trade Order ("CTO"). After

addressing comments from both the British Columbia Securities Commission (“BCSC”) and the Ontario Securities Commission (“OSC”), and completion of an updated NI 43-101 technical report (completed by P&E Mining Consultants Inc. from Brampton) on the Company’s Glover Island Property, Mountain Lake received a Revocation Order of its Cease Trade Order (Citation: 2017 BBCSECCOM 214) on June 28, 2017.

Subsequently, the CSE required that Mountain Lake Minerals complete a new Listing Statement (Form 2A) prior to resumption of trading in securities. The Company anticipates completion and acceptance of its new listing statement in early July, at which time trading of shares on the CSE (CSE: MLK) will resume.

The Company’s current assets include a 100% interest in its Glover Island Gold Project and its Little River Gold-Antimony Property. Both properties are located in Newfoundland, Atlantic Canada.

Management remained focused on attaining a successful revocation of its CTO, completion of quarterly financial statements, and pending exploration work plans.

Mountain Lake also continued its on-going discussions with several companies regarding both potential option and financing opportunities, in addition to potential acquisition of several additional assets.
