Report on Business

DST is engaged in the development and commercialization of environmentally friendly technologies for the treatment of complex materials from the mining industry. Through the development of patented, proprietary processes, DST extracts precious and base metals from ores, concentrates and tailings, while stabilizing contaminants such as arsenic, which could not otherwise be extracted or stabilized with conventional processes because of metallurgical issues or environmental considerations.

DST's most advanced proprietary process is the extraction of precious metals using a chlorination process which provides a cyanide-free alternative for the exploitation of gold deposits. DST's Thetford facility is a state of the art crushing, grinding, mineral processing (hydrometallurgy and pyrometallurgy) facility which is available for test programs from the lab scale up to the thousands of tonnes scale, as shown by the completion of two gold chlorination demonstration campaigns.

DST also operates a pilot plant designed to demonstrate its arsenic stabilization process for the sequestration of arsenic in a stable glass form. This process is becoming an attractive solution to segregate the arsenic and is therefore opening opportunities for materials considered to contain too much of this toxic material to be exploited or stabilized using conventional approaches.

In addition, DST provides technical expertise and the use of its world class laboratory, piloting and/or industrial demonstration facilities to clients in the graphite, cobalt, magnesium and lithium markets who wish to further evaluate the development of their projects in need of viable processing capacities, and to initiate engineering studies required for an industrial implementation.

In February 2018, DST entered into an agreement with the National Research Council of Canada ("NRC") for research services for the analytical characterization of auriferous arsenic-bearing mineral samples (the Service). The Service will provide valuable additional information to DST pursuing its technical work on arsenic-bearing mineralized materials such as arsenopyrite and cobaltite. DST is being provided \$99,900 from NRC-IRAP in support of this work.

Work has started on DST's first industrial scale arsenic vitrification plant (the "Plant") to be delivered to a metals facility (the "Facility"). As per the overall schedule, the construction and commissioning of the Plant that is built and assembled in Thetford Mines, Quebec is expected to be completed in the third quarter of 2018 for shipment to the Facility with the operation period starting during the last quarter of 2018. During the operation period, the Plant will process flue dusts produced by the Facility. The Plant is expected to produce up to 8 tonnes per day of glass which will contain up to 20% arsenic. This project has been approved for funding from the Government of Canada, through the SD Tech Fund, of up to \$1,250,000 (Please refer to press release dated January 24, 2018).

On January 8, 2014, Dundee Corporation ("Dundee") agreed to loan \$3,000,000 to the Corporation (the "First Loan"). The funds from the Loan were disbursed on January 31, 2014. The First Loan is secured by the Corporation's assets (the "Security"), bears interest at the rate of 12.68% per annum. The interest is payable concurrently with the repayment of the First Loan.

On July 3, 2014, Dundee agreed to make available, under certain conditions, an additional \$3,000,000 to the Corporation ("the "Second Loan") under the same terms as the First Loan of January 8, 2014. From July 4 to December 31, 2014 an aggregate of \$2,650,000 was advanced by Dundee to the Corporation.

On July 10, 2014, Dundee sold, transferred, assigned and conveyed the Bridge Loans to its wholly-owned subsidiary, Dundee Resources Limited.

On February 19, 2015, the principal amount of the Second Loan was increased to \$4,650,000 and the maturity dates of the First and Second Loans were extended to the earlier of November 30, 2015 and the date at which the Corporation raises the sum of \$10,000,000 or greater by way of debt or equity. An additional advance of \$2,000,000 was advanced to the Corporation during the six months ended June 30, 2015.

In January 2016, the principal amount of the First Loan was extended to the earlier of May 31, 2016 and the date in which the Corporation raises the sum of \$10,000,000 or greater by way of debt of equity, excluding any investments by Investissement Quebec, Dundee Resources or any of its affiliated companies.

In May 2016, the principal amount of the First Loan was extended to the earlier of November 30, 2016 and the date in which the Corporation raises the sum of \$10,000,000 or greater by way of debt or equity, excluding any investments by Investissement Quebec, Dundee Resources or any of its affiliated companies.

In November 2016, the principal amount of the First Loan was increased to \$5,150,000 and the maturity date was extended to the earlier of May 31, 2017 and the date in which the Corporation raises the sum of \$10,000,000 or greater by way of debt or equity, excluding any investments by Investissement Quebec, Dundee Resources or any of its affiliated companies.

In December 2016, Dundee Resources Limited advanced \$150,000 to the Corporation following the terms of the Second Loan and the amendment of November 2016. On February 2, 2017, an additional amount of \$200,000 was advanced to the Corporation. In May 2017, an additional amount of \$160,000 was advanced to the Corporation.

In May 2017, the maturity date of the First and Second Loan was extended to the earlier of November 30, 2017 and the date in which the Corporation raises the sum of \$10,000,000 or greater by way of debt or equity, excluding any investments made by Investissement Quebec, Dundee Resources or any of its affiliated companies.

On November 6, 2017, the Corporation signed a promissory note in the principal amount of \$500,000 payable on demand to a wholly-owned subsidiary of Dundee along with interest at a rate of 18% per annum.

On February 21, 2018, the Corporation signed a promissory note in the principal amount of \$400,000 payable on demand to a wholly-owned subsidiary of Dundee along with interest at a rate of 18% per annum.
