


Investment Focus and Approach

- Professional management approach to pursue high returns at acceptable risk
- Focus on pre-public investments with near-term go public events – not available to most investors
- Preference for convertible debt when available
- Emphasis on value drives focus outside of Canada
- Exposure to cultivation, extraction, pharmaceuticals, ancillary services
- Exposure to Canada, the United States, Columbia, Jamaica, Australia, Uruguay, Israel
- Diversification across numerous names leads to frequent liquidity events
