On March 15, the Issuer announced a sponsorship partnership between XenoHolographic and SportTechie (www.sporttechie.com), the world's leading digital media company covering sports technology.

On March 19, the Issuer announced that it retained the services of Hill+Knowlton Strategies (H+K), an international public relations firm.

The Issuer also announced that it had closed a non-brokered private placement financing ("Placement") for aggregate gross proceeds of C\$972,949.60.

On March 22, the Issuer announced the appointment of Tian Tai law firm to represent the Issuer in China.

On March 29, the Issuer announced a corporate update on a number of key strategic initiatives, recent corporate and financial developments, as well as forward progress on recently announced projects. One being a new partnership in certain specific projects between XenoHolographic and NBW Management, LLC, also known as New Brave World.
