**SULLY PROJECT UPDATE**

**Vancouver, Canada, June 28, 2018** – Kootenay Zinc Corp. (the “**Company**”) (CSE:ZNK; OTCQB:KTNNF; FSE:KYH) announces results of eight analyses from recently completed DDH SY18-17 on the Sully claims. As previously reported numerous fine grains of Sphalerite were observed throughout the hole. Intervals sampled were from 0.3 to 1.3 metres long of typical examples of the mineralization. The analytical work was done by Bureau Veritas Mineral Laboratories in Vancouver and consisted of 45 element ICP and whole rock analysis suites. As expected a variation in zinc and lead was observed. One sample is anomalous in zinc and lead and corresponding indicator elements Cd, Sb and Bi are elevated; two samples have elevated zinc and lead; in the balance of samples most elements appear to be at background levels. The one anomalous sample (0.3 metres long) with 1406 ppm zinc and 401 ppm lead has clustering of minute grains and wisps of sphalerite and is approximately directly down dip of a surface outcrop from which grab samples assay 1% Zn.

These results suggest a setting such as the margin of a hydrothermal up-flow zone, that is, it is possibly the volume of weak mineralization adjacent to a vein system feeding a SEDEX deposit at a higher stratigraphic level. The Kootenay King mine, 3.5 kilometres north of Sully and a small number of showings to the south of Sully occur at the top of the Kootenay King Quartzites, and these rocks are present on much of the east portion of, and dip into, the claim. In comparison, scattered visible sphalerite is present several hundred metres from the known vein system on North Star Hill, 3 kilometres south of Sullivan. The North Star deposit is an erosional remnant of a stratiform body at the same stratigraphic level as Sullivan.

Systematic exploration of the Kootenay King Horizon along the 4 kilometre east portion of the Sully claim should be pursued in conjunction with ongoing efforts to explain gravity and magnetometer anomalies at the projected stratigraphic level of Sullivan on the west and central parts of the claim.

The Company has decided that based on the results of the most recent drill program, the Company will not pursue the sully project and has terminated its option agreement with the vendors of the project.

## **About the Company**

Kootenay Zinc Corp. is a mineral exploration and development company based in Vancouver, British Columbia that is presently targeting the Sully Property. The Company is focused on discovering large-scale sedimentary-exhalative (“SEDEX”) deposits.

The Sully Property comprises 1,375 hectares located approximately 30 kilometres east of Kimberley, B.C., and overlies rocks of similar age and origin as those which host the world-class Sullivan deposit, owned by Teck Resources Ltd. Sullivan was discovered in 1892, and is known to be one of the largest SEDEX deposits in the world. Over its 100-year lifetime, Sullivan produced approximately 150 million tonnes of ore, including approximately three hundred million ounces of silver, eight million tonnes of zinc and eight million tonnes of lead. The equivalent level of strata as at Sullivan and that formed on the margin of that same basin are present at the Sully Property. The Company cautions that past results or discoveries on proximate land are not necessarily indicative of the results that may be achieved on the Sully Property.
