[The Issuer is an exploration stage company whose primary activities are acquiring and exploring mineral properties. The Issuer has a 100% interest in the Monster Property located 80 km north of Dawson City, Yukon, it has a 10% working interest in the Wels Gold project located in the Yukon, it has entered into](#)

an acquisition agreement to acquire a 100% interest in a resource exploration property located in Quebec known as the Barachois Property and it recently staked a 40 claim 2000 Ha nickel-copper-platinum group elements project in Quebec. The Issuer continues to seek opportunities in its primary activities.

2. Provide a general overview and discussion of the activities of management.

During the month of **March 2019**, management's principal activities consisted of preparing and filing its second quarter financial statements and MD&A for the period ending January 31, 2019, providing an update regarding the structural interpretation it received on the Monster Property and general administration matters.

During the month of **March 2019**, the Issuer provided an update on the structural interpretation it obtained on the Monster Property. Highlights include:

- Four fault sets have been mapped across the property using new satellite imagery;
- Northeast and northwest trending fault sets (ENE) help explain the depth of exposure;
- An east-northeast set partly controls the iron oxide alteration;
- The combined fault dataset provides the Issuer with a structural model that explains the depth of magnetic anomalies;
- The new data will help integrate different datasets such as the magnetic inversion and the pending gravity reprocessing; and
- The structural framework gives the Issuer a more accurate picture for 3D target definition on the Monster Property.
