In November 2018 the issuer reported that the Company has completed the purchase of 822 federal US mining claims in four blocks (approximately 6,871 hectares) in Lemhi County, Idaho from American Cobalt Corp. in the Idaho Cobalt Belt, collectively known as the "Champion Projects." As compensation for the Champion Projects, Idaho Champion issued 4,000,000 shares on February 20, 2019.
