On May 3, the Issuer announced that, as a result of AgraFlora Organics International Inc.’s sale of its interest in AgraLeaf SA, Liberty Leaf has subsequently sold its own interest in that company. This officially terminates the proposed joint venture in Greece with AgraFlora.

On May 28, the Issuer announced that it had signed an agreement with Canvas MedTech Inc. (“Canvas”), a leading digital cannabis education and analytics company, whereas Canvas shall be the exclusive provider of unbiased cannabis education for Liberty Leaf.
