The Company reported last month that on August 15, 2019, it announced that in furtherance of its proposed fundamental change transaction with 1157630 B.C. Ltd. (the "Transaction") and proposed spin-off of its mineral properties (the "Spin-Off"), both the Transaction and the Spin-Off were approved by the shareholders of the Company by a 99.9% margin on August 8, 2019. Additionally, the Company received

the final approval from the B.C. Supreme Court at a hearing held on August 12, 2019.

The Company remains focused on both its BC-based cannabis business and its Atlantic Canada-based precious and base metal exploration and resource development opportunities.

The Company has completed its 2019 exploration program at its flagship Newfoundland mineral property, the Caledonia Brook Gold Project. The four (4) person crew carried prospecting, and rock and soil sampling. Initial results are anticipated in early November at which point they will undergo careful QA/QC. Once results are evaluated the Company will determine next steps for its continued exploration. Numerous areas containing high concentrations of sulphide mineralization, pervasive alteration and brecciation encountered during exploration provide encouraging potential for new mineralization. The area is known to contain underlying lithologies like Marathon Gold's Valentine Lake Gold Deposit located further to the southwest of the Caledonia Brook property.

Management continues its focus on matters related to the completion of its announced Transaction and Spin Out, and evaluation of potential new mineral property acquisitions in Eastern Canada. The Company anticipates a resumption in trading very soon. The total number of outstanding shares in Mountain Lake Minerals remains at 12,282,962. Progress is ongoing with regard to listing the new Spin Out company on the TSX-V.
