On December 16, the Issuer announced that its subsidiary, Just Kush Enterprises Ltd. (“Just Kush”) had been issued standard cultivation, standard processing and sale for medical purposes licences from Health Canada under the *Cannabis Regulations* in respect to the company's fully constructed, state-of-the-art, cannabis cultivation facility situated on 13 acres in the Okanagan Valley, B.C.

On December 19, the Issuer announced that Just Kush had entered into a genetics purchase and services agreement with Vintages Organic Cannabis Company Inc., a wholly owned subsidiary of Rubicon Organics, Inc. (“Rubicon”), whereas Just Kush shall provide to Rubicon new rare genetics to expand its genetic library, in exchange, Rubicon shall support Just Kush with services including assistance with cannabis sales and certain crop consulting.

Further to receipt of its Health Canada Licenses, Management's focus this month has been to work closely with the Just Kush cultivation team.

In addition, management continues to seek out potential cannabis related ventures to increase shareholder value.
