The Issuer signed a multiyear distribution agreement with Volta Air Technology and Thermobile, a Southern California-based delivery vehicle retrofitter, focusing on refrigerated delivery vans for multiple use cases and industries, including cannabis and food. The agreement will open a strategic sales channel for the company in California, enabling it to scale the delivery of logistics and cold chain tracking technology in a key target market. The California logistics market, alongside Europe and Canada, represents a \$6.2-billion (U.S.) opportunity for the company.

The Issuer also has installed it’s proprietary temperature monitoring software in one of the first all-electric refrigeration delivery vehicles demonstrated for commercial use in North America. BYD Motors is the largest electric vehicle manufacturer in the world, with plans to offer all-electric refrigeration delivery vehicles throughout North America -- Berkshire Hathaway Inc. is one of its largest shareholders. The demonstration vehicles use Volta Air's latest transport refrigeration unit, equipped with the Issuer’s real-time cold-chain monitoring and tracking software to create and establish "zero-emission" refrigerated delivery vehicles.
