In July 2020, the Issuer:

- On July 31, 2020 the Mission South Chicago dispensary formerly known as Mission South Shore re-opened to patients and customers.

- On July 22, 2020, the Company received its special use permit for an additional retail location in Calumet City, Illinois
- Continued its cultivation optimization project in its Georgetown, Massachusetts facility.
- On July 30<sup>th</sup>, 2020, the Company received final approval to commence adult use sales at its Georgetown, MA facility

Management is focused on infrastructure initiatives to support the production capabilities in markets in which the Company operates, the development of additional assets in legal medical and adult-use cannabis markets, the continued growth of its core vertically-integrated cannabis assets, and divestment of non-core assets. Additionally, management is focused on growing the Company's footprint in the cannabinoid wellness space.

On July 7, 2020, the Issuer completed the third tranche of the previously announced private placement of convertible notes, and issued US\$138,037 in principal amount of newly-issued unsecured convertible notes (the “Unsecured Notes” convertible into Class A subordinate voting shares (“SVS”) at the option of the holder thereof at a conversion price of US\$0.46 (equivalent on the date of issuance to C\$0.60), as adjusted in accordance with the terms of the Unsecured Notes. The conversion right expires at 5:00 p.m. (Toronto time) on the earlier of: (i) the maturity date of the Unsecured Notes; and (ii) the date fixed for redemption of the Unsecured Note in accordance with its terms.

The maturity date of the Unsecured Notes is the earlier of (i) five years from the date of the issuance of the Unsecured Note; and (ii) such earlier date as the principal amount of such Unsecured Notes may become payable.

The interest rate of the Unsecured Notes is a rate of 3% per annum, provided, however, that if consolidated gross revenue of the Issuer for the applicable year exceeds US\$15M, the applicable interest rate will instead be 0% per annum.

On July 23, 2020, the Issuer completed the fourth tranche of the previously announced private placement of convertible notes and issued US\$1,359,366 in principal amount of Unsecured Notes on the same terms and conditions as stated above.

On July 31, 2020, the Issuer paid \$180,572.09 in interest on the \$32,000,000 in convertible notes (“Notes”) issued in November 2018 to entities associated with Gotham Green Partners LLC (“GGP”). The Notes mature in November 2021, bear interest at LIBOR + 11% during the first year, +10% the second, and +9.5 in the third, and are convertible into 4Front proportionate voting shares at a price equivalent to US\$0.83 per subordinate voting share. Half the interest due is paid in cash monthly, and half is paid in kind.

On July 31, 2020, the Company paid \$250,000.00 of principal and \$409,996.53 of interest to LI Lending, LLC
