If the Transaction is not completed by the Completion Deadline, the Company will return the Offering proceeds to the subscribers. Each Unit will be comprised of one common share in the capital of the Company (a "Common Share") and one Common Share purchase

warrant (a “Warrant”). Each Warrant will entitle the holder to purchase one Common Share (a “Warrant Share” and collectively, the “Warrant Shares”) at a price of \$0.11 per Warrant Share (subject to adjustment in accordance with the terms and conditions of the certificate evidencing such Warrants) (the “Exercise Price”) for a period of 24 months following the date of issuance thereof, subject to acceleration if the ten day volume weighted average price of the Common Shares on the Canadian Securities Exchange is equal to or exceeds \$0.35.
