In November 2020, the Issuer:

- The Company announced that it had completed its previously announced bought deal prospectus offering of units of the Company, for aggregate gross proceeds of \$17,251,150, including full exercise of the over-allotment option granted to the underwriters in connection therewith.
- The Company announced that its fully funded state of the art 185,000 square foot production facility in Commerce, California is nearing completion and will be ready to serve the \$3b California cannabis market in Q2 2021. The project is on target to be completed in April 2021 with the Company planning for the first of its full line of edibles, tinctures and vape products to be on California retail shelves by May.
- Continued its cultivation optimization project in its Georgetown, Massachusetts facility.
- Continued its cultivation expansion project in its Elk Grove Village, Illinois facility
- Continued construction at its Calumet City location.

Management is focused on infrastructure initiatives to support the production capabilities in markets in which the Company operates, the development of additional assets in legal medical and adult-use cannabis markets, the continued growth of its core vertically-integrated cannabis assets, and divestment of non-core assets. Additionally, management is focused on growing the Company's footprint in the cannabinoid wellness space.

During the month ended November 30, 2020, the Issuer paid \$155,379.92 in interest on the \$30,300,000 in convertible notes ("Notes") issued in November 2018 to entities associated with Gotham Green Partners LLC ("GGP"). The Notes mature in November 2021, bear interest at LIBOR + 11% during the first year, +10% the second, and +9.5 in the third, and are convertible into 4Front proportionate voting shares at a price equivalent to US\$0.83 per subordinate voting share. Half the interest due is paid in cash monthly, and half is paid in kind.

On November 30, 2020, the Company paid \$250,000.00 of principal and \$388,229.17 of interest to LI Lending, LLC
