These securities are being issued with respect to the acquisition of services from Mackie Research Capital Corporation for Capital Markets Services.

On January 21st, 2020 Imagination Park Technologies Inc. (CSE: IP) (OTC: IPNFF) announced that they had retained the services of Mackie Research Capital Corporation to act as financial advisor to the Company.

Mackie Research will provide advisory services to Imagination Park, including, but not limited to, capital markets advisory, financial and operational analysis, and recommendations on strategic growth objectives. The Company has agreed to retain Mackie Research for a term of six months, and the arrangement may be extended by mutual agreement.

As part of the compensation for its services, the Company will (i) issue to Mackie Research 3,000,000 common shares in the capital of the Company, (ii) grant 1,500,000 broker warrants to Mackie Research. Each broker warrant entitles the holder to purchase one common share at an exercise price of \$0.05 at any time up to 24 months following the date hereof.
