On February 6, the Issuer announced that its wholly-owned subsidiary, Signature by Liberty Leaf (“Signature”), had signed an exclusive affiliate marketing agreement with Global Alliance Foundation Fund (“GAFF”). The exclusive agreement between Signature and GAFF is for a 1-year term with 15% of every medical vaporizer purchase order generated by GAFF going directly to the organization, enabling it to provide guidance to individuals and non-profit veteran groups by empowering them with the tools and support needed for sustaining quality of life.

Further to receipt of its Health Canada Licenses, Management's focus this month has been to work closely with the Just Kush cultivation team.
