Argo Gold also has 3 gold projects peripheral to Wesdome Gold Mines Ltd.'s operations in Wawa. Drill targeting has also begun at the Abbie Lake Gold Project where historic drilling includes 4.5 feet of 0.45 oz/ton Au and 3 feet of 0.34 oz/ton Au.
