The cities and states for these locations are, Orlando FL (x2), Jacksonville FL (x2), St. Petersburg FL, Ormond Beach FL, Carbondale IL, Clarksville TN, Detroit MI and Dallas TX.

In September 2021, the Issuer opened its fifth psychedelic-assisted psychotherapy (PAP) clinic in Raleigh, N.C.

In September 2021, the Issuer launched telemedicine counselling as an additional service offering. The Issuer continues to lead in revolutionary ways by offering telemedicine counselling, a cutting-edge mental health coaching platform allowing the entire nation access to necessary services.

The Issuer currently employs over 20 mental health therapists, including psychologists, licensed clinical social workers and licensed professional counselors all trained in solution-based, goal-oriented coaching. Telemedicine provides the Issuer's patients access to their expertise through a comfortable platform which eliminates the taboo environment that often deters individuals from seeking help.
