The Issuer has acquired N8 Essentials LLC (“N8”), a US-based manufacturer and seller of wellness products incorporating CBD and other cannabinoids and functional ingredients, through its wholly-owned subsidiary Socati Corp. (“Socati”), for aggregate consideration of US\$790,000, to be satisfied through an issuance of common shares of the Issuer.

2. Provide details of the acquisition including the date, parties to and type of agreement (eg: sale, option, license etc.) and relationship to the Issuer. The acquisition is pursuant to an equity purchase agreement between Socati, N8 and the members of N8 (the “Members”) dated October 13, 2021 (the “Purchase Agreement”). The purpose of the transaction is to pursue synergies and the potential for vertical integration between N8’s manufacturing capabilities and the Issuer’s growing global wellness platform.

On the terms and conditions set out in the Purchase Agreement, Socati acquired all of the issued and outstanding equity interests in N8 from the Members, who are unrelated to the Issuer and its affiliates, for aggregate consideration of US\$790,000, which has been satisfied through the issuance of 1,173,847 common shares of the Issuer (the “Consideration Shares”) at a price per share of US\$0.673 (CAD\$0.853).

The Consideration Shares issued to the Vendors are subject to a contractual lock-up, with 25% of the Consideration Shares being released on each of the 10-month, 16-month, 22-month and 28-month anniversaries of completion.

## Appendix A

### PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9

The Canadian Securities Exchange and its subsidiaries, affiliates, regulators and agents (collectively, “CSE or the “Exchange”) collect and use the information (which may include personal or other information) which has been provided in Form 9 for the following purposes:

- To determine whether an individual is suitable to be associated with a Listed Issuer;
- To determine whether an issuer is suitable for listing;
