On September 17, 2021, the Company announced the hiring of new key project management leadership and administrative functions to meet demands from clients. The Company is expecting to continue to add needed staff for laboratories and field personnel for COVID-19 screening tests over the coming months.

The Company also announced that it has reached an agreement with an arms-length creditor pursuant to which it will settle outstanding indebtedness totalling \$579,310 through the issuance of 2,000,000 common shares at a deemed price of \$0.27 per share. The creditor has agreed that the common shares issuable in connection with the settlement will be subject to restrictions on resale for a period of twenty-four months following issuance.
