On September 30, 2021, the Issuer announced the sale of its minority shareholding in IXL PremFina Ltd ("PremFina"). The Issuer invested in PremFina in 2017. The proceeds from this divestment will be used to make new strategic investments that align with the Issuer's value proposition, contributing to the Issuer's growing investment portfolio in fintech, blockchain, and cryptocurrency technology companies worldwide. The divestment sum represents less than 3% of Fineqia's market capitalisation.
