On January 25, the Issuer announced that it had been included in the world’s first North American Psychedelic Index.

On January 26, the Issuer announced that it had commenced the diagnostic and treatment phase of its ongoing preclinical model study of autism spectrum disorder (ASD). In this model, which is well accepted by neuroscientists, pregnant rats are exposed to valproic acid (VPA) and the resultant offspring have ASD behavioral symptoms.
