On March 10, 2021, Pac Roots and Rock Creek Farms Ltd. entered into an amending agreement in respect of the investment agreement dated June 30, 2020 relating to the proposed industrial hemp joint venture. The amendments extended the date for closing of the respective investments of the parties to March 15, 2021 and amended the proposed ownership structure for the joint venture from 60% to be held by Pac Roots and 40% by Rock Creek Farms to 49% to be held by Pac Roots and 51% by Rock Creek Farms. As a result of the ownership structure changes, Pac Roots' capital contribution were also amended from \$450,000 to \$300,000 and Rock Creek Farm's capital contributions from \$300,000 to \$310,000.

These changes were made to for accounting purposes. All contributions have now been made and the joint venture entity to manage the operations was created with Pac Roots now holding a 49% interest and Rock Creek holding a 51% interest and the parties have entered into a Shareholder's Agreement dated March 11, 2021 in respect of the joint venture company.

On March 19, 2021 the issuer announced a new Frankfurt Quotation under the symbol FSE:4XM

On March 29, 2021 Jim Henning resigned as Corp Secretary and remains CFO. Anna Dalaire was appointed by resolution as VP of Corporate development and Corporate Secretary.

On March 30, 2021 the Annual Audited FS and MD&A were posted on SEDAR.
