On May 18, the Issuer announced it had entered into a drug-supply agreement with Laboratorium Ofichem BV (“Ofichem”). Under the terms of the agreement, Ofichem will supply the Issuer with GMP quality N,N-dimethyltryptamine drug substances for upcoming formulation, preclinical, clinical, and post-approval commercialization phases under the European Medicines Agency regulatory framework.
