On August 12, the Issuer announced it had filed for orphan drug designation with the European Medicines Agency (EMA) for its propriety psilocybin drug to help treat patients with fragile X syndrome (FXS), the leading genetic cause of symptoms related to autism spectrum disorder (ASD).

On August 20, the Issuer announced that it had entered into a Shares for Debt Settlement Agreement to issue 101,904 common shares a director of the Issuer at a deemed price of \$0.105 per share, thereby extinguishing \$12,700 in liabilities.

Management’s focus has been on furthering its clinical work in ASD/Fragile X and setting up its serotonin research center in partnership with FourthWall Testing.
