On September 10, the Issuer announced it has entered into a consulting agreement with Soykan Garipoglu to provide investor relations services.

On September 16, the Issuer announced that its wholly-owned subsidiary, Mobilum OÜ, had generated an estimated record Total Transaction Volume (TTV) of approximately CAD \$7.7 million in August 2021, which represents 44% month-over-month growth from the previous month.
