On September 7, the Issuer announced that it is expanding its psilocybin research and development program to target obesity and diabetes.

On September 14, the Issuer announced it had filed an application with the U.S. Food and Drug Administration (FDA) to receive orphan drug designation for its proprietary psilocybin drug to treat patients with fragile X syndrome (FXS), the most common inherited cause of autism spectrum disorder (ASD).

Management’s focus has been on furthering its clinical work in ASD/Fragile X and setting up its serotonin research center in partnership with FourthWall Testing.
