On November 2, the Issuer announced that the U.S. FDA has approved the Company’s proprietary psilocybin drug Orphan Drug Application to treat patients with fragile X syndrome (FXS), the most common inherited cause of autism spectrum disorder (ASD).

On November 9, the Issuer announced that it had filed a genetic neuroinflammatory disease patent which describes a diagnostic/therapeutic combination of mRNA molecules that encode proteins involved in the development of neurogenerative diseases, including FXS and ASD.
