2006 as a North American pioneer in the voluntary carbon credit market. The Issuer continued to provide solutions to clients globally in sequestering, capturing and reducing CO₂ while producing high quality fungible Carbon Credits. Delta is currently in the process of registering its operations in UAE to develop business opportunities in the region.
