On November 7, 2023, the Issuer announced that the equipment pursuant to a purchase agreement dated July 12, 2023, between its wholly owned subsidiary, MAI Cloud Solutions Inc. and a third-party customer (the "Purchase Agreement") has been installed.

On November 21, 2023, the Issuer announced that it has received the first payment in the amount of approximately \$143,000- in connection with the delivery of the equipment under the Purchase Agreement.

Pursuant to the terms of the MOU, the Issuer is working to procure and deliver approximately 17 million additional hours per year of Al compute time resources to be sold as services to an arm's length third party resulting in the sale of approximately 85 million Al compute hours over the next five years.
