In March, the Company released a shareholders update disclosing the completion and key highlights of the audit for the financial year ended June 30, 2025. Raffles Financial Group reported a total comprehensive income of S\$10.14 million for the year.

With the completion of the audit conducted by Auditor HML PLT, the Company immediately submitted applications to the Canadian Securities Exchange (CSE) and the OTCQX for the resumption of trading of its common shares.

The Company completed and filed its audited Annual financial statements for the year ended June 30, 2025 and the related Management's Discussion and Analysis.

Mr. Huang Chuan resigned from his position as Chief Executive Officer. Ms. Zhang Liying (Abigail Zhang) has been appointed as the new Chief Executive Officer.
