SQID Technologies Limited [CSE: SQID] is an Australian based Company engaged in payment solutions and investment portfolio management. It provides merchant services and payment transaction processing to business merchants and ecommerce customers across both Business to Business (B2B) and Business to Consumer (B2C) segments through its leading partner's platform (Merchant Warrior).

For the month ended 31 May 2026, unaudited payment solutions revenue was A\$16,947 (2025: A\$16,297).

For the five months ended 31 May 2026, unaudited payment solutions revenue was A\$68,511 (2025: A\$64,510).

During the period, Director Michael Clarke acquired 1,566,950 common (ordinary) through an at arm's length off-market transfer from First Growth Limited (CSE:FGFL). The shares were acquired at a price of CAD\$0.005 per share being the same price as the Placement completed in December 2025.

Mr Clarke now controls a total of 3,533,516 share representing a 16.3% interest in the total shares on issue.
