In July 2021, the Issuer:

- a) attended the Vintage & Handmade Society Market at the Vancouver Art Gallery in Vancouver, BC as a vendor and displayed it's Urban Juve products (including the new Asana Body & Massage Oil);
- b) completed shipping of Jusu Wellness home, body and cleaning products to 21 Healthy Planet retailers across Canada, as well as Vegan Supply Co. in Vancouver,
- c) received a product order for Urban Juve from Blush Lane Market in Calgary and The Beauty Room in Ontario,
- d) donated Jusu juices to the Mustard Seed in Calgary, to the South Island Volleyball Association in Victoria, and to City Reach in Vancouver; and,
- e) filed its second quarter financial results for the period May 31, 2021, including its interim consolidated financial statements, management and analysis, and CEO and CFO certifications on its profile on [www.sedar.com](http://www.sedar.com).

During the month of July, the Issuer entered into supplier agreements with seven Whole Foods locations in Ontario. Additionally, the Issuer entered into supplier agreements with a Happy Planet location in Ontario, and a Vegan Supply location in British Columbia.

An agreement was entered into on June 23, 2021 to terminate an operating agreement between Jusu Wellness Inc. and FastTask Inc. dated June 25, 2018.

An action was filed in the Court of Queen’s Bench of Alberta on February 26, 2021 by Brookfield Place (Calgary) LP by its General Partner Brookfield Place (Calgary) GP Inc., as Plaintiff, against CRU Juice Inc. (the “Tenant”), carrying on business as Jusu Bars, Bruce Wayne Mullen, 8931429 Canada Inc. and the Issuer, as Defendants. The claim is made in respect of a dispute regarding termination of a commercial lease for retail space in Brookfield Place Calgary. The Plaintiff seeks to recover compensation in the amount of \$60,000 from the Tenant and wishes to void the purchase of the Jusu Bars assets by the Issuer. A Statement of Defence was filed by the Issuer on April 12, 2021. The Issuer has denied all allegations on the basis that it entered into a commercial transaction to purchase assets from Jusu Bars and has no connection with the Tenant. In the Statement of Defence, the Issuer seeks dismissal of the claim against the Issuer and costs on a solicitor-client basis.
