During the month of December 2022, the Issuer continued to explore and develop its various lithium projects.

On December 12, 2022, the Issuer re-filed its financial statements and associated documents for the first quarter ended July 31, 2022 on its profiles on www.sedar.com and www.thecse.com.

On December 13, 2022, the Issuer announced results it received on an expanded set of surface sample assays from its Thompson Valley Property (the "TV Property") in Arizona. The results of surface sampling to date on the TV Property confirm the widespread presence of significant (>200 ppm) lithium concentrations in surface lithologies, and the Issuer plans to move forward with core drilling in early 2023 to test a target area identified from the surface sampling, subject to obtaining the necessary permits.
