- that DeVisser Gray LLP was re-appointed as the auditor of the Issuer;
- for the consolidation of common shares on a ratio of one post-consolidated common share for up to every six pre-consolidated common shares of the Issuer, as more particularly described in the management information circular of the Issuer dated October 23, 2023 (the "Consolidation").

On November 30, 2023, the Issuer announced that it had received shareholder approval to proceed with the Consolidation with a ratio of six pre-consolidated common shares for each one post-consolidated share via a news release filed on it's www.sedarplus.ca and www.thecse.com profiles.
