<u>During the month of January 2024, the Issuer continued to explore and develop its</u> various lithium projects.

On January 11, 2024, the Issuer announced that, through its wholly owned subsidiary Oakley Ventures USA Corp. ("Oakley"), the Issuer had successfully

negotiated Surface Use Agreements (SUAs) with the ranchers that have grazing rights overlapping its Arizona State Mineral Exploration Permits and nearby private surface lands at its Thompson Valley Project ("TV Project"). This was a major milestone in acquiring approvals necessary for a Phase 1 drilling program at the TV Project.

In the same announcement, the Issuer stated that Oakley had advanced its Right-of-Way (ROW) application with Arizona State Land Department to cross an adjacent mineral lease to enable access to the eastern area of the TV Project lands. The SUAs and ROW application are described in greater detail in the Issuer's press release dated January 11, 2024 and filed on the Issuer's profiles on www.sedarplus.ca and www.thecse.com.
