Report on Business

This month the Issuer launched its Contract Development and Manufacturing Organization (CDMO) business unit and signed its first two (2) contracts.Furthermore, the Issuer has enlisted MZ Group for investors relations services, investment awareness outreach and financial media relations.

The Issuer also wishes to report its continuous efforts in various key areas for the month of December:

a) **Scaling Up VINIATM Manufacturing:** The Issuer remains dedicated to expanding the production of VINIATM red grape cells at its newly established 20+ Ton facility. This expansion is crucial to meet the escalating demand for VINIATM as part of the marketing efforts for 2024.

b) **VINIA[™] Nutraceuticals New Product Development:** The Issuer's R&D team is actively working on the VINIA[™] Professional Protein Energy Bar Supplement, Electrolyte Powdered Beverage offerings and a higher dosage nutraceutical product for athletes. Additionally, significant progress is being made by the Issuer in getting its Olive cell product ready for a market launch scheduled for the latter half of 2024.

c) **VINIA[™] Direct to Doctors:** Dr. Brian Cornblatt, under whose guidance we operate, continues to collaborate with key distribution partners within the Integrative Medicine Market to facilitate the direct engagement of VINIA[™] with healthcare professionals.

d) **VINIA[™] New Clinicals Pipeline**: Dr. Brian Cornblatt, Chief Medical Officer, is diligently advancing our red grape cell product and future olive cell product with 3rd party research organizations. In addition, the Issuer is making the required arrangements for a clinical trial it plans to do on its new hydration proposition to validate its functional performance. This trial will commence in Q1, 2024.

e) **Pharmaceuticals Pipeline:** The Issuer continues to identify and engage with several candidates for leadership positions for its Phyto-Pharmaceutical business unit which the Issuer is setting up to lead clinical trials addressing priority indications which will form the foundation of its botanical drug pipeline.

f) **Cost of Goods Sold (COGS) Reduction:** In the pursuit of enhanced profitability, the Issuer, under the leadership of the Chief Operating Officer, continues to direct resources towards reducing manufacturing costs along the entire value chain. Over recent months, the Issuer has been actively transitioning its major subscription package from a combination of 60 bottle and 30 bottle units to a single 90-bottle package. The Issuer is also making progress in increasing the size of its bioreactors by 20% to maximize yield levels and reduce COGS.

2. Provide a general overview and discussion of the activities of management.

Since the events of October 7th in Israel, the management team has committed to maintaining the normal course of daily operations. Management has identified the potential risk of airport closures and is strategically focused on exporting maximum levels of VINIA[™] material outside of Israel as a precautionary measure.

3. Describe and provide details of any new products or services developed or offered. The Issuer launched its Contract Development and Manufacturing Organization (CDMO) business unit. The CDMO business unit offers the Botanical Synthesis process in three steps: Step 1 (3-6 months) produces a small biomass of BIOLOGICS+ (plant derived complex molecule) with NRE expenses of US\$150k - US\$500k. Step 2 (6-9 months) delivers increased biomass for trials with NRE of US\$350k - US\$700k. Step 3 (9-12 months) scales up production with NRE between US\$1M - US\$1.5M. Successful development takes 15-24 months, costing US\$1.5M - US\$2.5M in NRE. Upon industrial-scale production post Step 3, a royalty-based payment model is initiated.

In addition, the Issuer's research and development team continues to be actively engaged in developing the VINIA[™] Professional Protein Energy Bar Supplement and Electrolyte Powdered Beverage.
